

Selection Process

Applicants may be self-sponsored and self-nominated. In addition, community members may nominate individuals with leadership qualities for the Leadership Hilton Head Island-Bluffton annual program.

Criteria for selection includes:

- Evidence of leadership abilities.
- Interest in community affairs.
- Potential to provide leadership to the Hilton Head Island/Bluffton area.
- Commitment to become more involved in the community.
- Desire to expand volunteer involvement.

Basic criteria for applicants includes:

- Residency or work in Hilton Head Island, Bluffton or Daufuskie Island for at least one year prior to September 1.
- Evidence of current and/or previous commitment to community service.
- Interest in volunteer or public office leadership roles.
- Potential for service within one's own organization.

The program curriculum provides broad-based leadership perspectives to familiarize participants with the area’s challenges, opportunities and resources.

It also includes a class initiated community project, which explores current needs and issues first-hand. The class members will also participate in civic and community activities.

Attendance & Financial Requirements

Attendance Requirements

The program runs from September through May and includes one overnight weekend retreat, one mid-week overnight trip and seven full-day classes held monthly.

The retreat and the May class are mandatory. Participants can miss no more than two of the other seven classes to graduate the program.

Tuition

Current tuition is \$900 and covers all expenses for the program.

It may be paid by the individual, or by a sponsoring business or organization. Each class member must invest at least 10% (\$90) of his or her own money into the tuition payment.

A very limited number of partial and 90% scholarships can be applied for and are available on an as-needed basis.
