1. How to Enter: Beginning at 5:01 p.m. Eastern Time ("ET") on December 16, 2019 until 5:00 p.m. ET on July 31, 2020 (the "Promotion Period"), you may enter the "Golf Island Golf Trip Giveaway" (the "Promotion") by visiting the Hilton Head Island Golf website (<https://www.hiltonheadisland.org/golf/golf-island-golf-trip-giveaway>) (the "Website") and completing and submitting the online entry form. All entries must be received by the end of the Promotion Period to be valid. There is a limit of one (1) entry, per valid email address, per eligible person, per day. If multiple entries are received, only the first entry will be accepted and additional entries will be disqualified. Multiple participants are not permitted to share the same email address. How Winner will be Determined: The one (1) grand prize winner (the "Grand Prize Winner") will be selected in a random drawing from among all eligible entries on approximately July 31, 2020, and will be contacted by phone on or about August 2, 2020.
